**AVAILABILITY OF FUNDS:** In accordance with the Expedited Funds Availability Act, the first **\$200.00** of your check deposit will be available **on the first business day after the day of your deposit.** In some cases, we will not make all of the funds that you deposit by check available to you on the same business day we receive your deposit. If we are not going to make all of the funds from your deposit available on the same business day, we will notify you at the time you make your deposit. We will also tell you when the funds will be available. If your deposit is not made directly to one of our employees or if we decide to take this action after you have left the premises, we will contact you by the next business day after we receive your deposit. If you will need the funds from a deposit right away, you should ask us when the funds will be available.

### Member Identification Program

Beacon Financial will obtain a copy of your driver's license & a credit report when opening your account. Based on your credit rating Beacon Financial may offer you all of our services and products or may deny your account request. If you do not wish for Beacon Financial to obtain a credit report, we will not be able to open an account for you.
